Dear Parents and Kamper(s),

Welcome to Pensacourt's 2009 Kids Summer Kamp. I hope the following information will be helpful to assure that your child(ren) has an exciting and safe camp experience.

DRESS: We ask that everyone wear **comfortable clothing** each day to accommodate all the fun activities they will be participating in. Please have them wear shorts, t-shirts, **tennis shoes with SOCKS**, two (2) swimsuits (**PLEASE have your child WEAR their first suit under their clothes when they come to kamp each day**), two (2) towels, and **PLEASE send water shoes/flip flops for swim time only** (this helps keep their main shoes dry). Please DON'T let your child(ren) wear sandals or backless shoes. **Non-swimmers MUST bring a life vest**. Please bring a bottle of **SUNSCREEN** with their name marked on it (**please note spray, foam, or colored suncreens**). This bottle will stay during the session and be returned at the end of it. Each child(ren) need a **SMALL backpack/bag** to accommodate all of their personal belongings. **PLEASE LABEL ALL BELONGINGS (bag, lunch boxes, towels, etc.)!**

DROP OFF/

PICK UP: Please **escort** your child(ren) into the Kids Center building every day. You will sign your child(ren) in and out each time they come and go. **IF FOR ANY REASON** someone other than yourself will pick your child(ren) up please notify us by phone or note. If you know your child(ren) won't be attending camp on any days, please notify us by 8:00 a.m.

LUNCH

& SNACK: Children need to bring their own lunch. Pensacourt will provide snacks, juice, and water. Children may also bring additional **HEALTHY** snacks (NO candy). **We ask that no child bring a LUNCHABLE with shredded cheese in it.**

FIELD TRIP

INFO: We will take the kids on a **field trip** each week. We will take the Pensacourt bus which is licensed with Children & Family Services. Your field trip has been paid for via your registration fee. Some field trips allow extra money. You will receive a session newsletter that will instruct you on the dates and exact information.

NEWSLETTER: On the first Monday of each session kampers will receive a newsletter telling them about all the fun they will enjoy during the upcoming two weeks, including field trip information, session themes, and more.

TOYS: We will keep the kampers extremely busy while they are here. It is not necessary for them to bring **toys** from home. We do allow children to bring their **game boys** to enjoy during kamper's choice time. It needs to be understood that they are responsible for their game boys and extra games and that these items need to be marked with the kamper's name.

Other Activities

Available: Private and group swim and tennis lessons are available during camp. Parents make the arrangements and let us know so we can walk the children back and forth to the pool/tennis courts.

PAYMENTS: **Session payments need to be made one (1) week prior to the first Monday of each session. If the fee is not received by this time the space will be given to the next person on the waiting list. Remember, all fees are non-refundable.**

PLEASE NOTE: Parents are responsible for their OWN TAX INFORMATION. Your check will serve as your receipt. If you pay cash we will provide you with a receipt. Pensacourt does not issue tax statements. Our tax I.D. # is 59-2060017.

MEDICATION: If your child(ren) requires **medication** bring it in the original container to the camp office for distribution. You will also fill out a medication distribution form.

PENSACOURT'S 2009 KIDS KLUB MORNING KAMP (for Pensacourt Members)

Available to kids ages 5 - those completing 5th grade. Monday - Friday from 9:00am - 1:00pm. Cost is \$20 per day or \$25 per field trip day. This program requires enrollment 48 hours in advance and is based on availability. Fees are non-refundable. Kids need to bring one bathing suit and towel, wear sneakers, and either bring lunch or purchase one from us.

PENSACOURT'S 2009 DAILY KAMPERS - Open to everyone but based on availability.

Available to kids ages 5 - those completing 5th grade. Monday - Friday from 7:30am - 6:00pm (regular camp hours). Cost is \$35 per day or \$40 per field trip day. This program requires enrollment 48 hours in advance and is based on availability. Fees are non-refundable. Regular Kamp information applies.
